# General terms and conditions

1. Classes are held according to the schedule, which can be found on the homepage <https://www.nadiyapankovaart.com/art-school> (outside Bavarian school vacations).
2. The duration and cost of the classes depend on the chosen course (see "Terms and conditions of participation in the art course "KunstProstlR" by Nadiya Pankova"). In case of illness of the main teacher or his absence for other important reasons, Nadezhda Pankova reserves the right to appoint a substitute teacher, postpone the class to another date or cancel it altogether. The cost of the canceled class will be fully refunded to the participants. Participants will be informed in advance.
3. Participants must notify the instructor in advance of possible absences. Payment for a missed class will not be refunded.
4. The curriculum and teaching methods are determined by the teacher.
5. If students are unable or unwilling to follow the curriculum or interfere with other students' classes, this contract may be terminated unilaterally by the teacher, Nadia Pankova.
6. Materials and tools:
  - Learning materials requested by the teacher are provided by the students themselves. Students are required to bring their own materials to each class.
  - Students bring most of the materials and tools themselves. However, if there are not enough tools or supplies, students can use tools and materials from the workshop for a voluntary donation. If a student needs materials and tools, most of them can be purchased from the teacher. Paper for assignments can be purchased by the piece.
  - For students who do not plan to purchase materials and tools on their own, there is an option to pay a monthly fee for consumables in the amount of 24 euros for monthly or 5-time subscriptions.
7. The first lesson of the course is a "trial lesson" and is paid for only if the course is attended further. This "trial lesson" can be attended only once per course.
8. Registration is mandatory and obliges you to pay the course fee for the relevant period, continuously for all months, including holidays.
9. The cost of classes per month is calculated based on the schedule of weekends and holidays in 2023. The number of working classes per year (including weekends and holidays) is divided by 12 months. This means that participants will be charged for August as well. The trial lesson, which is the last lesson of the month, is always free of charge.
10. There is one exception that will result in a recalculation of the monthly amount:
  - a. Cancellation of classes for any reason, including teacher's illness and lack of a substitute.
  - b. The student plans to be absent for a valid reason (long-term (more than 2 weeks) illness, urgent long-term business trip, etc.) But only if the teacher is notified in advance!
11. During the summer holidays, Nadiia Pankova offers the Sommerworkshops program, which is also part of the curriculum and requires additional registration. The Sommerworkshops program is free for students who have signed a monthly or annual contract.
12. Nadiya Pankova offers online lessons in art theory and history, which are also part of the curriculum. These lessons are free for students of art courses.
13. Nadiya Pankova reserves the right to change the course schedule, as well as the form and system of payment.
14. All students and their families receive a 10% discount on all workshops and art parties organized by Nadiya Pankova.
